



IOWA GREAT LAKES LUTHERAN SCHOOL
RE-ENROLLMENT/TUITION AGREEMENT 2020-2021

It is the intent of Iowa Great Lakes Lutheran School (IGLLS) to provide quality education in a Christian setting for each child who is enrolled in our program. In order to do this successfully, we must plan for and meet our financial obligations.

There is a \$50 non-refundable registration fee per student due with this form. Technology fees are due at registration in August. There is a \$50 technology fee per student in grades K-2, and a \$100 technology fee per student in grades 3-6.

The actual cost to educate a student at IGLLS is \$6,200. Because of facilities and maintenance provided by First English Lutheran Church and monetary support from FELC, other Lutheran churches, and generous individuals, the tuition that is charged to families is considerably less than the actual cost.

The School Board has set the tuition for the 2020-2021 school year at \$3,180 per student. There is a multi-student discount of \$250 for each additional child enrolled from the same family. Tuition is broken into 10 monthly installments as a convenience to families. The first tuition installment is due on or before August 31. The next nine installments are due at the end of each month September through May. It may also be paid in its entirety at any time. Parents may sign up for automatic withdrawal from a bank account.

We ask that all families who may qualify to fill out Financial Assistance Applications for ILSTO by the deadline of April 24, 2020. You will need to submit a copy of your tax return with this application. Information about eligibility and applications are available in the office or at www.iowalutheransto.org. Families must apply for ILSTO funds in order to be considered for any further financial assistance from IGLLS.

In order to ensure that all parents have read and clearly understand the above issues concerning tuition payments, and to help us plan for next year, we ask that you sign and return one copy of this form to the school office with the registration fee by March 2, 2020. At that time, we will open enrollment to those not currently registered.

If you are enrolling a kindergartner, you will need to fill out an application. Contact the office.
